

## **MISO RELEASE FORM M-RETS**

### **Release**

This document is a Release (“Release”) between the entity identified in the signature block below (“Market Participant”) and Midwest Independent Transmission System Operator, Inc. (“MISO”).

### **Recitals**

WHEREAS, MISO has entered into a Service Agreement, dated as of September 26, 2007, as amended (the “Agreement”), with APX, Inc. (“Administrator”) to provide generator-specific information to supply a multi-state renewable resource tracking system (“M-RETS”);

WHEREAS, MISO may only provide information to Administrator as required pursuant to the Agreement for each Market Participant who has executed this Release;

WHEREAS, Market Participant is a Market Participant, as that term is defined in MISO’s Open Access Transmission and Energy Markets Tariff accepted by the Federal Energy Regulatory Commission, who desires MISO to release to Administrator information in the MISO’s market settlement system on energy injections for one or more generating units owned by such Market Participant or for which Market Participant has a contractual right to the energy injections; thus, the Market Participant’s consent is required prior to disclosure by MISO of such information;

WHEREAS, Market Participant agrees to consent to such disclosure and to grant MISO permission to disclose the applicable generator-specific information or Commercial Pricing Node (“CPNode”)-specific information to Administrator.

Therefore, the parties agree as follows:

### **1. Disclosure of Generator Data**

Market Participant hereby irrevocably and absolutely consents to and authorizes MISO providing Administrator with all of the Market Participant’s energy injection data that was settled through MISO Settlement process for the CPNode(s) specified on this Release. Market Participant also agrees to the inclusion of its name and specific generator name or names of the CPNodes specified on this Release being listed in Exhibit C of the Agreement; such Exhibit C may also be posted on MISO’s website. Market Participant must also identify MISO as the Qualified Reporting Entity on the Generator registration within M-RETS.

### **2. Release and Indemnification**

Market Participant hereby releases, discharges, holds harmless and agrees to indemnify MISO (its officers, employees, agents, representatives, successors, assigns, and anyone authorized by MISO) from any and all claims and demands arising out of or in connection with the use, reuse, publication, republication, and editing of energy injection data provided to Administrator by MISO pursuant to this Release.

If the foregoing correctly sets forth the understanding and agreement between MISO and

Market Participant, Market Participant consents to and authorizes the disclosure by MISO to Administrator, its respective affiliates, attorneys, advisors and other representatives, of the Market Participant's energy injection data solely for the purposes described herein, please so indicate in the space provided for that purpose below, whereupon this Release shall constitute a binding agreement between MISO and Market Participant as of the date that this Release is signed and returned to MISO.
